# Foreword

The Swedish Government Offices Yearbook was first produced in 1998. The purpose of the Yearbook is to provide a picture of the activities within the Government Offices of Sweden during the year. The Yearbook's Appendix also provides current facts and figures as part of this picture.

During the first half of 2023, Sweden held the Presidency of the Council of the European Union. It was an exciting but also challenging task that left no part of the Government Offices' activities unaffected. Moreover, 2023 was marked by the ongoing insecurity in our neighbourhood due to Russia's invasion of Ukraine. In anticipation of Sweden's accession to NATO, preparations in the Government Offices for NATO membership continued during the year. On 1 January 2023, the Swedish Government's new grouping of ministries came into force.

The Government Offices, whose task is to support the Government in governing the country and putting its policies into practice, consists of the Prime Minister's Office, the government ministries, and the Office for Administrative Affairs. The ministries are each responsible for particular policy matters, and the Office for Administrative Affairs is responsible for providing support, service and development to the Government Offices as a whole. The Prime Minister's Office leads and coordinates the work of the Government Offices. Officials, who are not political appointees, support the Government and the political appointees by inquiring into various matters, drafting legislative proposals, drafting budget proposals, providing background material for the governance of government agencies, developing relationships with other countries and preparing various decisions and positions in negotiations, for example within the EU.

It is my hope that this year's Yearbook will provide some greater insight into the activities of the Government Offices. Please also visit our website [www.regeringen.se](http://www.regeringen.se).

# Sweden's Presidency of the Council of the EU January–June

From 1 January to 30 June 2023, Sweden held the Presidency of the Council of the European Union for the third time. In this role, Sweden chaired roughly 2 000 meetings in Brussels and Luxembourg, and roughly 150 meetings in Sweden.

With the goal of contributing to a greener, freer and more secure Europe, Sweden's presidency prioritised security, competitiveness, and the green and energy transitions, as well as democratic values and the rule of law. A particular focus was support to Ukraine, where Sweden acted to maintain unity within the EU and sustain deliveries of military, humanitarian and political support.

# Facts about the Government Offices

## **Organisation of the Government Offices**

In 2023, the Government Offices comprised the Prime Minister's Office, ten ministries and the Office for Administrative Affairs. The Government Offices is a single government agency headed by the Prime Minister. This means that the Prime Minister is both head of government and head of the Government Offices. At the beginning of the year, a ministry reorganisation resulting in the cessation of the Ministry of the Environment, the Ministry of Enterprise and Innovation, and the Ministry of Infrastructure. The reorganisation added the Ministry of Climate and Enterprise, and the Ministry of Rural Affairs and Infrastructure.

In the day-to-day work of the Government Offices, the Prime Minister is assisted by a state secretary at the Prime Minister's Office, the Permanent Secretary at the Government Offices and the Director-General for Legal Affairs at the Prime Minister's Office. The leadership of each ministry comprises one or more ministers, one of whom is head of ministry. Every minister is supported by state secretaries, political advisers, press secretaries and ministry officials. The Office for Administrative Affairs is headed by the Permanent Secretary.

Missions abroad – i.e. embassies, representations, delegations to international organisations such as the EU, the UN and the OECD, and career consulates – are separate authorities that are directly responsible in administrative terms to the Government Offices.

The Government appoints committees of inquiry and inquiry chairs. These are independent government agencies that report to the Government.

### Duties of the Government Offices

“The Government Offices is responsible for preparing government business and assisting the ministers in other aspects of their work.” (Section 1 of the Ordinance concerning the Duties of the Government Offices [1996:1515]).

### Duties of officials

The Government Offices has approximately 4 900 employees, including some 200 political appointees. Those who are not politically appointed retain their posts regardless of the government in power. They are responsible for assisting the Government by preparing background material and developing proposals for government decision-making, and examining national and international issues. They also deal with issues related to the governance of government agencies, preparing data for the annual appropriation directions and following up agency activities. International negotiations, for example in the European Union, are also part of their work.

### Government Offices activities

The Appendix section of the yearbook contains descriptions of the Government Offices' activities in a number of statistical measures that reflect its activities in various ways. The information can be divided into seven main activities that can be described in brief as follows:

## 1. The legislative process

The task of the officials is, on instruction from the Government, to process policy initiatives, formulate terms of reference for committees of inquiry, and prepare background material for decisions. They also circulate reports for comment, prepare proposals for referral to the Council on Legislation, draft government bills, and prepare the issuing of legislation passed by the Riksdag.

## 2. The budget process and agency governance

Government Offices officials prepare documentation and proposals for the central government budget, analyse and follow up the budget, prepare the instructions and appropriation directions that steer government agencies, participate in the appointment of agency boards and agency heads, and maintain regular contact with the government agencies.

## 3. Government business

Government Offices officials prepare government business. This includes government bills, written communications, instructions to government agencies, appropriation and grant matters, and certain administrative matters.

## 4. Work at EU and international level

The Government Offices is tasked with preparing Swedish positions and pursuing negotiations in the EU, and preparing proposals on how best to incorporate EU directives into Swedish law. Government Offices' officials also represent Sweden in other international negotiations, including in the UN system.

## 5. External communication


The Government Offices staff assists the Government in communicating with the world at large. For example, officials draft input to ministerial responses to questions and interpellations from the Riksdag and prepare replies to letters and e-mails from the general public.

## 6. Special projects and programmes 2023

Special projects and programmes are activities of an administrative nature that are undertaken by the Government Offices. These activities run for only a limited period of time.

## 7. Internal support

Government Offices officials are involved in internal operational planning, financial administration, human resources issues, IT support, security services, archiving, registration and facilities planning.



# Policy areas at the ministries in 2023

## **Prime Minister's Office**

The Prime Minister's Office is responsible for leading and coordinating the work of the Government Offices and for coordinating Swedish EU policy. An average of 225 officials worked at the Prime Minister's Office during the year.

## **Ministry of Employment**

In 2023, the Ministry of Employment was responsible for issues and items of government business concerning the labour market, labour law and the work environment. The Ministry was also responsible for integration matters, the work to combat exclusion and for greater gender equality. In addition, the Ministry was responsible for the work on human rights at the national level, strengthening the rights of LGBTQI people, and the work to combat racism and discrimination. An average of 177 officials worked at the Ministry during the year (including committees of inquiry).

## **Ministry of Finance**

In 2023, the Ministry of Finance was responsible for issues concerning central government finances. This included coordination of the central government budget, forecasts and analyses, tax issues, and the management and administration of central government activities. The Ministry was also responsible for matters concerning financial markets, municipalities and regions, public procurement, state-owned enterprises, digitalisation and IT, and consumer legislation. An average of 608 officials worked at the Ministry during the year (including committees of inquiry).

## **Ministry of Defence**

In 2023, the Ministry of Defence was responsible for matters concerning Sweden's military defence, the coordination of civil defence and Sweden's crisis preparedness as well as the prevention of accidents. The Ministry also plans international deployments and security-building activities at the strategic level, and tasks government agencies with implementing and following up these deployments. An average of 216 officials worked at the Ministry during the year (including committees of inquiry).

## **Ministry of Justice**

In 2023, the Ministry of Justice was responsible for among other things for the judicial system, which includes the Swedish Police, the public prosecution service, the courts, and the Swedish Prison and Probation Service. The Ministry is also responsible for migration issues. Legislation in the areas of constitutional and public administration law, private law, procedural law, criminal law, public order and safety, and migration and asylum law also fell within the Ministry's sphere of responsibility. An average of 367 officials worked at the Ministry during the year (including committees of inquiry).

## **Ministry of Climate and Enterprise**

In 2023, the Ministry of Climate and Enterprise was responsible for issues related to the climate, the environment, energy, enterprise and innovation. The Ministry was also responsible for radiation safety, the 2030 Agenda for Sustainable Development, and outdoor recreation, and works with the transition to a circular economy. An average of 337 officials worked at the Ministry during the year (including committees of inquiry).

## **Ministry of Culture**

In 2023, the Ministry of Culture was responsible for issues related to culture, democracy, the media, Sweden's national minorities, and the language and culture of the Sami people. An average of 113 officials worked at the Ministry during the year (including committees of inquiry).

## **Ministry of Rural Affairs and Infrastructure**

In 2023, the Ministry of Rural Affairs and Infrastructure was responsible for issues affecting rural areas, food and agricultural industries, for regional development, and for transport and infrastructure, as well as for housing and spatial planning. An average of 289 officials worked at the Ministry during the year (including committees of inquiry).

## **Ministry of Health and Social Affairs**

In 2023, the Ministry of Health and Social Affairs was responsible for issues concerning society's well-being such as public health, health and medical care, and care of older people. The Ministry's areas of responsibility included social insurance, so that people remain financially secure when they are sick, older or when their children are small. Issues concerning individual and family care, support for people with disabilities, and care of older people were also included. In addition, the Ministry has worked with rights for people with disabilities, and with issues concerning the premium pension system. The Ministry was also responsible for issues related to sport, youth policy, civil society, religious communities and the undertaking and funerals system. An average of 330 officials worked at the Ministry during the year (including committees of inquiry).

## **Ministry of Education and Research**

In 2023, the Ministry of Education and Research was responsible for the Government's education and research policy. The Ministry worked with issues such as school outcomes, teachers' conditions and student finance. An average of 201 officials worked at the Ministry during the year (including committees of inquiry).

## **Ministry for Foreign Affairs**

The Ministry for Foreign Affairs is responsible for Sweden's relations with other countries and international actors, and for development aid and international trade policy. The Ministry for Foreign Affairs and Sweden's representation abroad, which consists of approximately 100 missions, together constitute the Foreign Service. An average of 1 285 officials worked at the Ministry for Foreign Affairs during the year (including committees of inquiry), of whom 506 were stationed at missions abroad. In addition, an average of about 1 250 staff were locally employed at missions abroad.

# The Government Offices' internal development work

The Government Offices needs to develop continuously to provide effective support to the Government and to be an attractive employer. Development through the digitalisation of the Government Offices core and support processes is a priority area.

During the year, the focus of the Government Offices' development work (the focus plan) was updated. The starting points for the plan are the management's focus, external factors and the needs of the Government Offices' activities. It was developed jointly within the Government Offices and guides their long-term development. The focus is based on the keywords consistency, digitalisation and flexibility.

The implementation of a digital working method for government business and business within the ministries has continued. Its introduction has begun and is being phased in gradually. This means, as examples, that decision documents are now created, reviewed and certified digitally. This development will contribute to better process efficiency, improved product quality and better interaction with external actors.

Another high priority has been the development of administrative support processes, such as the introduction of a new accounting model that is to be used consistently and support the needs of the entire Government Offices. In 2023 a preliminary study began following the change of payroll system for the National Government Service Centre. This included a review of the human resources administration processes.

Preparations for Sweden's application for NATO membership were carried out.

The employer policy priorities for 2023–2026 set by the Human Resources Director have guided the development of the Government Offices' employer policy. During 2023, the focus has been on strengthening leadership and employeeship in the Government Offices.

# The Swedish Government in 2023

Every four years, the Swedish people elect their representatives to the Riksdag (the Swedish Parliament). The Riksdag appoints a Prime Minister, who is tasked with forming a government.

Since 18 October 2022, Sweden has been governed by a coalition consisting of the Moderate Party, the Christian Democrats and the Liberal Party.

# Introduction

Changes around the world mean ever increasing complexity requiring faster processing times in the Government Offices. Policy matters are sometimes transferred between ministries, and ministries may be reorganised. A review of the Government Offices' tasks can also result in certain decisions and administrative business being transferred to other government agencies. Caution is therefore required when making comparisons over time and between ministries.

One example is the ministry reorganisation that took place in January 2023. This meant that the activities of the Ministry of Infrastructure, the Environment and Enterprise were reorganised into two newly formed ministries: the Ministry of Climate and Enterprise, and the Ministry of Rural Affairs and Infrastructure.

Also, a number of policy areas were transferred between ministries in connection with the reorganisation, which affects the figures in the Appendix.

The Government Offices continuously reviews the internal division of tasks between the ministries and the Office for Administrative Affairs to ensure effective and uniform operational support to the Government.

# 1. The legislative process

The Riksdag passes new legislation and legislative amendments. Most legislative proposals are initiated by the Government.

Before the Government presents a legislative proposal, an inquiry or a committee of inquiry is often appointed with a remit to study a specific issue by gathering facts, analysing them and presenting proposals. The inquiry or committee receives its instructions through the terms of reference of the inquiry or committee which are decided by the Government. An inquiry or committee of inquiry is usually appointed for a limited period of time. During the course of the inquiry, it may prove necessary to extend or modify the remit. In that case, the Government can decide on supplementary terms of reference. These supplement the original terms of reference and generally also extend the duration of the inquiry.

A committee consists of a committee chair and one or more members. A committee with members from parties represented in the Riksdag is called a cross-party committee of inquiry. Inquiries can also be assigned to a single individual, who is then called an inquiry chair. Committees and inquiry chairs can also be assisted by inquiry secretaries, advisers and experts, among others.

When the committee or the inquiry chair has completed its work, a final report containing proposals is presented to the Government. These reports are published regularly in the Swedish Government Official Reports series (SOU). Legislative proposals may also be studied and drawn up within the Government Offices. Some of these proposals are reported on in ministry memorandums which are published regularly in the Ministry Publications Series (Ds).

Before the Government adopts a position, the proposals are circulated for comment to the relevant government agencies. Municipalities, interest groups and individuals are also given the opportunity to comment. Once this consultation process is complete, a government bill is drafted specifying the legislation proposed. In addition to the legislative proposal, the government bill includes an explanatory statement, comments on the proposal, and a presentation of the views of the referral bodies. Often, the Council on Legislation is consulted through a proposal being referred to it for consideration before the bill is submitted to the Riksdag.

A government bill containing a legislative proposal is considered by the Riksdag, resulting in a parliamentary decision. If the Riksdag adopts the legislation, it is promulgated by the Government. The legislation is then published in the Swedish Code of Statutes (SFS) on the website [www.svenskforfatningssamling.se](http://www.svenskforfatningssamling.se).

Sometimes, the Government outlines its position on a particular matter without submitting any proposals to the Riksdag. Such reports are called written communications.



## 2. The budget process and agency governance

Work on the central government budget begins more than a year before the start of the relevant budget year. In December each year, the Ministry of Finance presents the Government with forecasts of how the national economy and public finances are likely to develop.

At the end of February, the government agencies submit their annual reports for the previous year and their budget data for the coming three-year period. This material is analysed by the ministries. In February and March, the Ministry of Finance also continues its work on reviewing and updating the revenue and expenditure forecasts in the central government budget, central government's borrowing requirements, etc. During this period, the other ministries also revise the forecasts for their respective expenditure areas and appropriations.

Deliberations on the focus of the central government budget then take place in March. Guidelines for economic policy and the central government budget for the coming years are laid down in the Spring Fiscal Policy Bill, which is presented to the Riksdag in April. At the same time, the Government submits a central government annual report for the previous year.

The Spring Fiscal Policy Bill focuses on the guidelines and challenges for economic policy and budget policy over the coming years. Detailed proposals on new reforms are reported in the autumn Budget Bill. During the spring, meetings are held with the government agencies (agency dialogues) in which the political leadership and the agency leadership go through the agency's activities from both a retrospective and forward-looking perspective. The ministries also work on the reports that are submitted to the Riksdag for each expenditure area in the Budget Bill. During the spring and summer, the ministries prepare the amount of funding that will be divided into individual appropriations.

The Government submits the Budget Bill to the Riksdag by 20 September. In an election year, the Bill must instead be submitted no later than three weeks after a vote in the Riksdag has confirmed that the Prime Minister has sufficient support in the Riksdag, or three weeks after a new government has taken office if there has been a change in government.

The Budget Bill contains proposals on expenditure ceilings for central government expenditure. The expenditure ceiling for an individual budget year is decided three years in advance, which is why the proposal applies to the third year ahead. The Budget Bill contains proposals for revenue estimates for all budget revenue, proposals for preliminary expenditure limits for the 27 expenditure areas and proposals for the allocation of expenditure to appropriations in each expenditure area. In addition, proposals on preliminary expenditure limits and revenue estimates are submitted for the coming second and third budget years. The Budget Bill also reports the outcome of government activities in each expenditure area during the previous year as background material for the budget proposal.

In connection with the Spring Fiscal Policy Bill and the Budget Bill, the Government may submit proposed amendments to the central government budget. This is done in a Spring Amending Budget or an Autumn Amending Budget. If special grounds exist, government bills with amendments to the central government budget can also be submitted on other occasions as ‘additional amending budgets’.

While the Riksdag discusses the Budget Bill, the ministries begin drafting the appropriation directions for the government agencies under their jurisdiction. The appropriation directions set out the financial powers that the government agencies need for their activities, as well as the objectives, reporting requirements and assignments that apply for the year. In November, the Riksdag decides on the budget revenue and expenditure limits for all expenditure areas, and in December it decides on the amount and purpose of each appropriation in the relevant expenditure area. The Government subsequently decides on the appropriation directions before the end of the year.

## Summary of the central government budget, SEK billion

For 2023 the budget process involved the allocation of just over SEK 1 224 billion. The following tables show the revenue and expenditure outcomes for the central government budget in recent years in current prices.

## **Agency governance**

The central government agencies that report to the Government are the Government's foremost tools for implementing the policies decided on by the Riksdag and the Government. The governance of public administration must be results-oriented, tailored to the activity, strategic, coherent and citizen-centric.

In Sweden, our government agencies are organisationally independent and have a far-reaching delegated responsibility to independently determine how they are to implement their tasks. Under the Government Agencies Ordinance (2007:515), each agency's management is accountable to the Government for the agency's activities. The agency's management is responsible for ensuring that the agency's activities are conducted efficiently and in accordance with the applicable legislation and the obligations that follow from Sweden's membership of the EU, that they are reported in a reliable and fair way, and that the agency manages government funds prudently. The Ordinance also contains special provisions governing the different forms of management. The Government is ultimately accountable to the Riksdag for everything that its agencies do. The Ordinance expects good monitoring of the agencies' results and activities, and that the Government will intervene if it determines that an agency is not handling its tasks appropriately.

The Government Agencies Ordinance and instructions are the main documents that steer the Government's long-term and strategic governance. The Government Agencies Ordinance and its instructions regulate each agency's tasks, management form and other circumstances specific to the agency. For some government agencies, the legislation governing an area of activity is also very important for how the agency designs and conducts its activities. Separate ordinances may also be important. Annual governance is via the agency's appropriation directions. In addition, there may be specific government decisions.

Another important governance tool for the Government is decisions on the appointment of directors-general and deputy directors-general, and of members of government agency boards, committees and advisory councils.

An important part of agency governance is following up the agencies' activities. One way this is done is through dialogue between representatives of the Government and the agency's management.

## 4. Work at EU and international level

Missions abroad – Sweden's embassies, consulates-general, etc. – represent the Government and the Government Offices around the world. Sweden's missions abroad reinforce the impact of the Government's policies, safeguard Swedish interests abroad and provide persons domiciled in Sweden with consular assistance abroad.

In pace with globalisation and Sweden's membership of the EU, the Government Offices' international and EU-related work has increased and is now extensive. The recent exacerbation of the global security situation and Sweden's road towards NATO membership have also contributed to this trend.

All ministries participate in EU-related work, which includes preparing Swedish positions, conducting negotiations, transposing EU directives into Swedish law, and monitoring infringement matters and cases before the European Court of Justice. Other examples of the ministries' international work include representing Sweden in international negotiations, such as within the UN system, and participating in various security and defence-related alliances. The ministries also take part in bilateral meetings with other EU Member States, organise international conferences and inform the Riksdag about Sweden's work in the EU and other international cooperation.



## 6. Special projects and programmes in 2023

Special projects and programmes are activities of an administrative nature that are undertaken by the Government Offices. They are financed by funds from the Government Offices' appropriation for administrative activities or from some other appropriation at the Government's or Government Offices' disposal. This could be when:

- the Government allocates project funds;
- the activity constitutes a platform for debate and opinion formation;
- the activity builds on collaboration with other parts of the central government administration or with other stakeholders in society; or
- the projects are intended to run for a limited period of time.

Special projects and programmes are only carried out in response to special needs or conditions. For example, the activity may not naturally fall within any other agency's sphere of responsibility. The activity may also cut across multiple sectors of society and require decisions to be taken regularly by the Government or an individual minister, which is difficult to define in a remit to one or more agencies. Programmes and projects are often an important complement to other Government activities.



## Proportion of women and men by staff category


This graph shows the proportion of women and men by staff category.



## Average age and average length of service


The graphs show average age and average length of service by staff category in 2023.

The average length of service varies substantially between staff categories. The overall average length of service in the Government Offices is 11 years. The short length of service among specialists is due to their appointments, often to committees, being on a fixed-term contract.


### Staff turnover

As shown in the data on the average length of service per staff category, many indefinite term employees have worked at the Government Offices for a long time. This is partly due to the opportunities that exist for moving to other positions at the Government Offices.

However, some Government Offices duties require specific professional experience from other sectors of society. This is particularly true for those employed under Government Offices specialist contracts, i.e. fixed-term appointments at ministries and on committees and inquiries. External staff mobility among ministry employees (excluding committee staff) was 15 per cent in 2023, and internal mobility between ministries was 5 per cent. In addition, officials change jobs within each ministry.

## Sickness absence


The sickness absence rate at the Government Offices was 2.3 per cent in 2023. Sickness absence was 2.8 per cent among women and 1.4 per cent among men in 2023. At the time of production of this Yearbook, the figures for the public sector as a whole for 2023 were not confirmed, but for comparison, the 2022 rate was 4.1 per cent.



## Sickness absence by age group

The graph below shows that, as in the community at large, in the Government Offices long-term sickness absence increases with age. A total of 5 per cent of employees at the Government Offices are 29 years old or younger, 52 per cent are between 30 and 49 years, and 43 per cent are 50 years or older.

## Parental leave and care of a sick child

Of the total number of working hours for women in the Government Offices in 2023, 2.8 per cent constituted parental benefit and 0.3 per cent care of a sick child. The corresponding figures for men were 2.1 and 0.3 per cent, respectively.

## **Equal pay**

Every year, a pay survey is conducted in collaboration with the social partners to detect, remedy and prevent unjustified differences in pay and other terms and conditions of employment between women and men at the Government Offices. The 2023 pay survey has not indicated any structural differences between men's and women's pay that need to be corrected.

## **Integration of the climate and environment in the Government Offices' preparatory processes**

Integrating the climate and environment in the Government Offices' preparatory processes is an important tool for achieving the national environmental and climate goals adopted by the Riksdag. The aim of the Government Offices' 2017 environmental policy for integrating the climate and environment into preparatory processes is to ensure that, where relevant, the climate and environmental impact of government decisions is consistently taken into account. This applies to decisions on new proposals and new policies, as well as new committees of inquiry and tasks to government agencies. This requires preparing relevant decision guidance documents that include climate and environmental analyses. The work on integrating the climate and environment is continuously monitored and developed. The Ministry of Climate and Enterprise is responsible for overseeing and reporting on this work to the Prime Minister each year. All ministry heads are responsible for this work in their own ministries. Their development work is intended to strengthen the central government's own work.

## **Activities with direct environmental impact (internal activities)**

The Government Offices works to ensure that consideration for the environment is a natural element of day-to-day work. Internal environmental action must be inclusive and open. The Government Offices identifies and reviews the adverse environmental impacts of its activities so that they can be avoided. The Government Offices continuously monitors, evaluates and improves its environment action based on an environmental management system developed in accordance with the environmental management standard ISO 14001.

The Permanent Secretary has decided on overall environmental goals and interim targets for the Government Offices' activities that apply for 2023–2025. The goals aim to:

- reduce the amount of waste resulting from these activities;
- ensure that the use of IT products and services is sustainable in the long term and beneficial to the activities;
- reduce carbon emissions through climate-smart meetings;
- use procurement and purchasing as a key tool to reduce negative environmental impacts; and
- create awareness and knowledge of environmental action in the organisation.

## Government Offices expenditure

The activities of the Government Offices, excluding transfers, are largely financed via the appropriation for administrative operations. Special activities and services are financed via programme appropriations. The tables below show the Government Offices' costs under the appropriation for administrative operations. Salaries and premises account for the bulk of the Government Offices' costs.
